All the District Educational Officers and Regional Joint Directors of School Education in the State are hereby informed that already certain guidelines were issued in this office in the references read above, on transfers of teachers. In addition to those guidelines, certain clarifications / instructions are issued as follows:

- i) If a teacher who worked as MRP and taken salary during the period of MRP from the same school i.e. where he worked prior to coming as MRP and now not working in the same school after his repatriation, such teachers shall apply for the entitlement points taking the present school service only i.e. where now he is working, and if he has not completed 2 years period in the present school, he is not eligible to apply for transfer.
- ii) If a teacher who worked as MRP and taken salary during the period of MRP from the same school i.e. where he worked prior to coming as MRP and also working in the same school after repatriation, the entire period shall be taken for computation of 8 years as well as for entitlement points and if found more than 8 years, they shall be compulsorily transferred. Their present places of working shall be shown as vacancy.
- iii) Just as MRPs, for the teachers who are working / worked as MLOs, the school from where they are drawing salary, shall be counted for computation of 8 years period as well as for entitlement points. The places of MLOs, who have completed 8 years of service will be shown as vacancies and they shall be asked to apply for transfer. If not applied for transfer and not attending counseling, they will be issued posting orders in absentia.
- iv) The Special Vidya Volunteers and Special Teachers (Rs. 398/-), whose service is considered for awarding of Automatic Advancement Scheme of 8 / 16 / 24 Years Scale and for retirement benefits by the Government. The date of their appointment shall be considered for awarding entitlement points for transfer purpose only.

Therefore, all the District Educational Officers and Regional Joint Directors of School Education in the State are requested to take action accordingly.
