The attention of all the District Educational Officers in the State is invited to the references 1<sup>st</sup> to 4<sup>th</sup> read above and they are informed that in the reference 1<sup>st</sup> read above, at para 3(c) to (e) , conditions were given for stepping up of pay for the senior with junior , if the junior is drawing more pay than the senior. In particular at point (c), it is stated that the benefit of pay fixation under F.R.22-B shall continue to be allowed on promotion even if the employee had derived the benefit under Special Grade Scale/Special Promotion post Scale-I . If this results in the senior drawing less pay than that of Junior, the pay of the senior should be stepped up with effect from the date of promotion of the junior, to a figure equal to the pay as fixed for the junior in the higher post to which he/she is promoted on or after 01-07-2008, subject to conditions from (i) to (viii).

Later the Govt in the reference 2<sup>nd</sup> read have issued modifying the Automatic Advancement Scheme by changing the periodicity from the existing 8/16/24 to 6/12/18/24 years for appointment under this scheme w.e.f 01-02-2010.

Further, the Govt. in the reference 3<sup>rd</sup> read above, at Sl.No.2 clarified that the periodicity of the Automatic Advancement Scheme from 8/16/24 to 6/12/18/24 has been changed w.e.f 01-02-2010 and the other conditions in GO.Ms.No.93 Finance(PC.II) Dept dt.03-04-2010 shall be continued.

The District Educational Officers are informed that in the reference 4<sup>th</sup> read above, .Government reiterated the provision of G.O.93, dated.03-04-2010 in giving clarification on stepping up of pay

Therefore, all the District Educational Officers are requested to take necessary steps for implementing Government orders with regard to stepping up of pay in respect of teachers.

This has the approval of the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad.
