Sub:- M.A.Dept. – Municipal Teachers – Guidelines/Instructions for Municipal Teacher Transfers 2018 under Phase-I i.e., Spouse, Mutual and request Transfers – Certain instructions - Issued – Regarding.

The attention of all the Commissioners of (59) ULBs in the State and all the RDMAs in the State are invited to the references cited, and informed that, Government in the reference 4<sup>th</sup> cited (copy enclosed) have issued certain guidelines to the Municipal Teacher Transfers 2018 to the various categories of Teachers working in the Municipal Management under Spouse, Mutual and request transfers of Inter Management / within and outside District. The following criteria shall be adopted while proposing transfers for Municipal Teachers.

The Municipal Teachers who have completed a minimum period of service for 3 years (as on 30<sup>th</sup> April, 2018) in a ULB is eligible for Transfer.

- Request transfers (Mutual, Spouse & Request grounds) shall be considered by the Government only in respect of employees fulfilling one or more of the conditions mentioned below:
  - a.  $\underline{\text{Mutual cases}}$ : Same category of post only shall be transferred.(One application only)
  - b. Spouse cases: Husband and Wife cases (only Municipal Teachers shall be shifted following the prescribed procedure). Teacher whose spouse belongs to State Government or Central Government or Public Sector undertaking by Govt. or Local Body or Persons working in the Institutions against the Aided post category in AP and working in the same District / Outside District may opt for transfer. Once the facility is utilized, the next request can be made only after eight years. The concerned HoD/Appointing Authorities shall issue the Service Certificate in respect of spouse working within/outside the AP State, as the case may be.

### c. Other Request cases:

- Disabled persons Orthopedically handicapped / Visually Challenged / Hearing impaired not less than 70% as certified by a competent authority – District Medical Board.
- ii. Employees having mentally challenged children to a place where medical facilities are available.

iii. Un-married / Widow / Divorced (female employees).

### iv. Medical grounds:

- 1. Teachers and their dependents suffering with Cancer, Open Heart Operations, Neuro Surgery, Bone TB, Kidney Transplantation/Dialysis to places where such facilities available (certificate issued by District Medical Board).
- Applicants with dependents Mother, Father, Spouse, Children who are mentally retarded and are undergoing treatment (certificate issued by District Medical Board).
- 3. Children suffering with holes in the Heart by birth and undergoing medical treatment available only at specified places to which they are seeking transfers (Certificate of evidence)
- 4. Applicants with dependent children suffering from juvenile Diabetes (Certificate issued by District Medical Board)
- While considering the request transfers based on above conditions, preference shall be given to the Municipal Teachers based on the entitlement points mentioned in G.O.Rt.No.506, MA&UD Department, dated 16.05.2018;

# 3) In case of a Tie in Points secured:

In case the entitlement points for two or more applicants are equal, the seniority shall be determined as below:

- 1. Applicants having disability (Ortho, Visual, Hearing) shall take priority, only on production of certificates.
- 2. Subject to the above, the seniority in the cadre shall be taken into account.
- 3. Priority to the candidate basing on the date of birth (older), besides (1) & (2) above.

### 4) Preferential categories:

The following categories shall take precedence in the seniority list, in the order given below, irrespective of their entitlement points.

- Disabled persons Orthopedically handicapped/ Visually Challenged/ Hearing impaired not less than 70% as certified by a competent authority – District Medical Board.
  - ii. Widows (Proof of evidence required)
- iii. Legally separated women (Certificate to be produced Issued by Court)
- iv. Head-Master/ Teachers and their dependents suffering with the following diseases and undergoing treatment (Proof of evidence from the listed Hospitals/ Certified by District Medical Board)
  - a. Cancer
  - b. Open Heart Surgery
  - c. Neuro Surgery
  - d. Bone TB
  - e. Kidney transplantation/Dialysis

- v. Applicants with dependents Mother, Father, Spouse, Children who are mentally retarded and are undergoing treatment (certificate issued by District Medical Board)
- vi. Children suffering with holes in the Heart by birth and undergoing medical treatment available only at specified places to which they are seeking transfers (Certificate of evidence)
- vii. Applicants with dependent children suffering from juvenile Diabetes (Certificate issued by District Medical Board)
- 5) Transfers on Mutual Grounds or request grounds shall not be done between the schools located in the same ULB.
- 6) Transfers on request shall be considered by the Government only against the existing clear vacancy except the leave / suspension vacancies.

- 2. Therefore, the Undersigned has decided the following Procedure to submit transfer applications through online in the CDMA Website @ www.cdma.ap.gov.in:
  - i). Eligible Teachers can apply transfer request through online form 18.05.2018 to 20.05.2018 as per following Procedure:-
  - ii). Teachers will fill all the relevant details in the application form available in www. cdma.ap.gov.in @ Teachers Transfers -2018 Application Form.
  - iii). After entering the details and on submission, an unique register Number (URN) will be generated to the Teacher.
  - iv) All the Teachers will ensure the filled details carefully before generating the URN No. Since once URN No. generated, there will not be any possibility for editing.
  - v). Accordingly, the Teacher details will be saved in PDF format @ details Saved successfully (pop-up).
  - vi). The Teacher can Download the PDF document @ Download PDF button at Top of the page. PDF cannot be downloaded if the window is closed.

- vii). After downloading the PDF application form, the Teacher shall submit the same with signature along with all supporting attested documents viz. spouse certificate, medical certificate, Service Certificates, willingness letter (to take last rank in the new station, as the case may be) etc.
- 3 a) After receipt of online generated application form together with necessary certificates from the applicant, the concerned Commissioner has to submit the same to the RDMA concerned, VMC, GVMC concerned in full shape with vacancy position, Service Certificate, No Allegation Certificate, No Due Certificate, Spouse Certificate, as the case may be from 21-05-2018 to 22-05-2018, without fail.
- 3 b) The Commissioners / RDMA are requested to identify the Transfer applications of the Teachers who are requesting the places which is beyond their respective regions and submit the same together with all enclosures, entitlement points in the below shown consolidated format, to DMA office on 21.05.2018, without fail, for taking further necessary action in the matter.
- 4. The RDMA / VMC / GVMC concerned will scrutinize the proposals received from the concerned Commissioners as per guidelines issued by the Government in the following manner;
  - a). The MIS reports of uploaded applications from 18.05.2018 to 20.05.2018 shall be generated and displayed through Login Credentials (User ID & password) to each Regional Director Offices (Visakhapatnam, Rajahmundry, Guntur and Ananthapur).
  - b). The uploaded Application Forms with its enclosures will be scrutinized as per guidelines issued by the Government and submit consolidated proposal in respect of the eligible Teachers as per the above guidelines, in the following format along with all necessary documents to the DMA by 25.05.2018 before 5.00 PM, without fail (i.e. Soft and Hard copies with signature).

- d) The Commissioners/ RDMAs are requested to verify the genuineness and the competency of the authority issued the certificates / documents submitted by the applicants.
- 5. Therefore, all the Commissioners of (59) ULBs and RDMA / VMC / GVMC are hereby instructed to adhere the above instruction scrupulously and allow only online applications for effecting transfer as per the guidelines/instructions issued by the Government, without fail.
- 6. The RDMA/VMC/GVMC is responsible for submission of the Municipal Teacher Transfer Proposals in the most transparent manner possible without giving any scope for complaints/ allegations. Any violation of these guidelines will be viewed seriously by the Government.
- 7. The requests of the teachers having any charges / ACB / Vigilance cases pending against him / her shall be not be considered for transfer. The authority shall indicate this fact clearly against the name of the employee if there is any request for transfer and no TA / DA will be paid to the employees as these transfers are effected at their request.
- 8. Any false information / certification given by the applicants proved in the later date, they shall be liable for disciplinary action as per APCS (CCA) Rules, 1991.

ORDER:-

In pursuance of the orders issued, lifting of ban on transfers vide reference  $2^{nd}$ read above, the Director of Municipal Administration, A.P., Guntur has submitted on transfer and posting guidelines / instructions vide letter in the reference 3rd read above based on the representation of various Teachers and Teacher Unions to effect the Municipal Teacher Transfers 2018 to the various categories of Teachers working in the Municipal Management under Spouse, Mutual, Inter Management/District/Inter district and request transfers.

After careful consideration of the matter, Government hereby issue the following 2. After careful consideration of the matter, Government hereby issue the following guidelines / instructions for transfers and postings to the various categories of Teachers working in the Municipal Management of the various categories of Teachers working in the Municipal Management under Spouse, Mutual and request transfers of inter management / within and outside District:-

Phase-I

Municipal Teacher's Transfers - Mutual, Spouse Cases & request transfers from one District to other District and within the District

A. Applicability:

Transfers shall be applicable to all categories of Teachers working in Municipalities / Corporations as per Service Rules, 2016 i.e. Gr.II Head Masters, School Assistants, Specialist Teachers, PSHMs, Secondary Grade Teachers and other equivalent categories working in all Municipal / Corporation Primary / Upper Primary/ High Schools in the State.

	All the Transfers shall be processed by applications filled by Teachers and submitted the same along with prescribed Format to the RDMAs concerned through the Municipal Commissioners concerned.

# **B.** Criteria for Transfers:

The Municipal Teacher who have completed a minimum period of service for 3 years (as on 30th April, 2018) in a ULB is eligible for Transfer.

  - a. Mutual cases : Same category of post only shall be transferred.(One application only)
- b. Spouse cases: Husband and Wife cases (only Municipal Teachers shall be shifted following the prescribed procedure). Teacher whose spouse belongs to State Government or Central Government or Public Sector undertaking by Govt. or Local Body or Persons working in the Institutions against the Aided post category in AP and working in the same District / Outside District may opt for transfer. Once the facility is utilized, the next request can be made only after eight years. The concerned HoD/Appointing Authorities shall issue the Service Certificate in respect of spouse working within/outside the AP State, as the case may be.

- 4. The requests of the teachers having any charges / ACB / Vigilance cases pending against him / her shall be not be considered for transfer. The authority shall indicate this fact clearly against the name of the employee if there is any request for transfer and no TA / DA will be paid to the employees as these transfers are effected at their request.
- 5. The Director of Municipal Administration, A.P, Guntur shall take further necessary action in the matter and he is also instructed that the Regional Director of Municipal Administrations concerned to follow the above guidelines during the transfers counselling very scrupulously within time limit as stipulated vide G.O. in the reference  $2^{nd}$  read above.
