ORDER:

Government after careful examination of the matter decided to amend the orders issued in G.O.Ms.No.26, Education (PE.Ser.II) Department, dated:21.06.2010. Accordingly the following amendment is issued.:

AMENDMENT

For para 6 of G.O.Ms.NO.26, School Education (PE.Ser.II) Department, dated: 21.06.2010, the following shall be substituted, namely:-

"In the circumstances stated above, the Government hereby permit the Commissioner and Director of School Education to fill up the posts of School Assistants, Physical Education Teachers and Language Pandits strictly in accordance with the notification issued and as per rules in G.O.Ms.NO.161, Education (Ser.VI) Department, dated: 06.12.2008 as amended in G.O. Ms. No.28, Education (Ser.VI) Department, Dt: 29-01-2009 and such candidates shall be initially appointed as apprentice teachers purely on ad-hoc basis in existing/arising vacancies subject to out come of pending court cases (APAT/High Court/Supreme Court of India) and orders of Government issued in consequence thereof".

In the annexure – I at Guideline 4 namely Listing of Vacancies after point (vi) the following shall be added:-

(vii) If the candidates who applied for two posts and selected for both posts, the selection, will be considered for the Higher post only, and selection in lower post will automatically will be cancelled to accommodate the next meritorious candidates in the selection list in the respective category and community. **However an option along with declaration should be taken from the candidate for the posts to which he/she opted for appointment and with the approval of District Selection committee his/her name should be deleted from the Merit list, then selection list should be prepared.**

(viii) No Physically challenged quota should be extended for the Physical Education Teacher posts as the said quota is not considered for admission into the Physical Education Training courses. And the post earmarked for Physical Education Teacher should be filled with eligible meritorious candidate as per Government. Memo.No.1351/Ser.VI/2008-2, dated: 01-04-2008.

In the annexure-I for Guideline 7 namely Issue of appointment orders the following shall be substituted:-

“Appointment orders shall be issued to the extent of available clear vacancies of the School Assistants/Physical Education Teachers/Language Pandit posts which are to be filled up strictly in accordance with G.O.Ms.No.161, Education (Ser.VI) Department, Dt: 06.12.2008, and G.O.Ms.No.28, Education (Ser.VI) Department, Dt: 29.01.2009. A review of availability of vacancies shall be made quarterly with the approval of District Selection Committee until filling up of entire notified School Assistants/Physical Education Teachers/Language Pandit posts in DSC-2008 notification, based on the retirement and promotion vacancies arose in the concerned districts. Every appointment order shall exclusively state that the appointment orders now issued are subject to outcome of cases pending before various courts and informing that the teachers shall be under apprenticeship for a period of two years initially”


