## ORDER:

In the light of the orders of the Hon'ble Supreme Court in the reference 5<sup>th</sup> read above, it is necessitated to amend Note 6 of Rule 3 of the rules issued in G.O.Ms.No.505, Education(Ser.I) Dept, dt: 16-11-1998 for promotions to the post of Deputy Directors/District Educational Officers. In the reference 8<sup>th</sup>, 9<sup>th</sup> & 12<sup>th</sup> read above, the three member Committee as constituted by the Commissioner & Director of School Education, Hyderabad has examined the Apex Court orders as well as the representations of various Organizations and submitted their report. After careful examination of the entire matter, Government, have decided to issue certain amendments to Rule 3 of G.O. Ms. No. 505, Education (Ser.I) Department, dated 16.11.1998 and accordingly the following amendments are issued.

2. The following Notification will be published in the Andhra Pradesh Gazette:

## NOTIFICATION

In exercise of the powers conferred under sub section (1) and (2) of Section 78 read with Section 99 of the Andhra Pradesh Education Act, 1982, the Governor of Andhra Pradesh hereby make the following amendments to the Andhra Pradesh Educational Service Rules issued in Rule 3 of G.O.Ms.No.505, Education (Ser.I) Dept, dt: 16-11-1998.

2. The amendments hereby made shall come into force with immediate effect.

## AMENDMENT

In the said rules, under Rule 3 Method of Appointment and appointing Authority:

 In Class II against Category 1 in Column 3 "Method of Appointment" for the existing entries, the following entries shall be substituted namely:-

"By promotion from categories 1,3,4,5 of Class III"



- For Note 6 there under, the following shall be substituted namely: "Note 6: For the purpose of promotion to Category 1 of Class II, the following 9 point cycle shall be followed from the feeder categories:
  - (1) Deputy Educational Officer
  - (2) Assistant Director
  - (3) Lecturer in CTE/IASE/SCERT
  - (4) Deputy Educational Officer
  - (5) Senior Lecturer in DIET
  - (6) Assistant Director
  - (7) Lecturer in CTE/IASE/SCERT
  - (8) Deputy Educational Officer
  - (9) Senior Lecturer in DIET"
- Government have also decided to effect promotions to the post of Dist. Educational Officer/ Deputy Director from the said feeder categories barring the Officers raised from the local bodies, if they come under zone of consideration, until finalization of the case of Unification of Service Rules pending before the Apex Court.
- The Commissioner & Director of School Education, Hyderabad shall take necessary action accordingly.
