2. In the G.O.1<sup>st</sup> read above, the State Government have adopted theinterest rate of 7.9% per annum with effect from 1.4.2017 to 30.6.2017, asordered by the Government of India.

3. In the reference 2nd read above, the Government of India through resolution No. F.No.5 (1)-B(PD)/2017, dated. 1.01.2018 announced the interest for the subscribers of General Provident Fund (Central Services)at 7.6 % per annum for the period from 01.01.2018 to 31.03.2018 during the year 2017-18.

Government after careful examination of the matter, hereby order toAdopt&revision the rate of interest as 7.6 % per annum for the periodfrom 01.01.2018 to 31.03.2018 during the year 2017-18 on the followingProvident Funds and other similar funds maintained by the Governmentof Andhra Pradesh on par with rates of Government of India.
