ORDER:

In the GO. 1st read above, Government have introduced a Scheme of Vocational Education during the year 1984-85 and 1985-86 in 345 schools based on the recommendation of the V.R. Reddy Committee. At present, the scheme is being implemented in 297 High Schools and in 48 Mandals Vocational Educational Centers in the State. 1030 Part-Time Vocational Instructors are being engaged in Government, Aided and Local Body High Schools to impart Vocational Education, and they are being paid an amount of Rs.3,500/- per month as honorarium. In the reference 2nd read above, the School Education Vocational Instructors Association, A.P., Hyderabad has represented to the Government, to regularize the services of Part-Time Vocational Instructors, who are working for the last 23 years.

- 2. In the reference 4th read above, Government have issued orders for regularization of services of 1030 Part Time Vocational Instructors who were re-engaged in the Schools in the State in June, 2008 for the academic year 2008-2009 in the existing Craft Teachers vacancies, in the scale of pay of Rs.5470-12385 by suppressing 1030 vacant Craft teacher posts with effect from the date of issue of the orders. The pay and allowances shall be debited to the relevant Head of Account under various Managements, as per rules in force, and also an amendment issued in GO. 5th read above, to absorb I regularize the services of 1030 Part Time Vocational Instructors, in the existing Craft Teachers vacancies
- 3. Govt. have issued instructions to Director of School Education, in the reference 6th read above, to see that the rule of reservation is complied at the time of recruitment of Vocational Teachers through District Selection Committee (D.S.Cs) and further to satisfy that all the qualifying conditions are complied with.
- 4. In the reference 7th read above, the School Education Vocational Instructors Association, A.P., Hyderabad has represented to the Government, to implement the orders issued in G.O.Ms.No.31 SE. (Prog.l) Dept., dt. 13.02.2009 to regularize the services of Part-Time Vocational Instructors. The Commissioner & Director of School Education, Andhra Pradesh, Hyderabad has furnished the particulars of the Part Time Vocational Instructors working and the vacancies of Craft Teachers available in the Districts roster point-wise under rule of reservation in the reference 8th read above.
- 5. Government after careful examination, hereby supersede I cancel the instructions issued in the reference 6th read above. And direct the Commissioner & Director of School Education, Andhra Pradesh, Hyderabad, to direct all the District Educational Officers in the State to implement the orders issued in G.O.Ms.No.31, School Education (Prog.l) Department, dated 13.02.2009, to absorb I regularize the services of 1030 Part Time Vocational Instructors who were re-engaged in the Schools in the State in June, 2008 for the academic year 2008-2009, duly relaxing the "Rule of reservation" as one time exercise and all of them be regularized by showing against future vacancies if need be, with effect from the date of issue of orders in the reference 4th read above, in the scale of pay of Rs.5470-12385. The pay and allowances shall be debited to the relevant Head of Account under various Managements, as per rules in force.
- 6. This order may be treated as a special case, not a precedent case, now or in future.
- 7. The Commissioner and Director of School Education, Andhra Pradesh, Hyderabad shall take necessary action, accordingly and furnish the compliance report to Government, immediately.
