All the District Election Officers are requested to direct all the Returning Officers to issue an "Election Duty Certificate" in the format appended to this order, to all the Presiding Officers and Assistant Presiding Officers, who have actually attended the duty in Polling Station, at the reception centre after handing over all the relevant election material so as to enable them to avail the said Special Casual Leave. The reserve Presiding Officers and Assistant Presiding Officers are not entitled for this facility.
