In the reference 1st cited, provision is made for transfer of a person from one local cadre to another cadre on a reciprocal basis subject to the condition that the persons so transferred shall be assigned seniority in the later cadre with reference to the date of his transfer to that cadre.

- 2. In the reference 2nd cited, Government have issued certain quidelines for effecting Inter District transfer of Teachers on Mutual grounds.
- 3. In the reference 3rd cited, Government have issued further instructions on the implementation of Presidential Order, 1975 and G.O.Ms.No.610, G.A. (SPF.A) Deptt. Dated 30.12.1985 laying down certain conditions for effecting "Inter Local Cadre transfers of employees".
- 4. In the reference 4th cited, Government have called for consolidated proposals for Inter District Transfer of Teachers on mutual grounds from the Commissioner & Director of School Education, Hyderabad.
- The Commissioner & Director of School Education, Hyderabad in the reference 5th cited have submitted proforma application for Inter District transfer of teachers and requested the Government to approve the same. The Government in the reference 6the read above while approving the proforma application requested the C & DSE, Hyderabad to send consolidated proposals for considering Inter District transfer of teachers on Mutual Grounds.
- 6. The Commissioner & Director of School Education, Hyderabad have received online applications for inter district transfer of teachers on mutual grounds and submitted the list of teachers of various categories vide reference 7th cited . Subsequently, C & DSE, Hyderabad have submitted another proposals for Inter District Transfer of 414 Teachers vide reference 8th cited.





7. In the meantime certain teachers who have submitted applications for inter district transfer have submitted representations to Government withdrawing their willingness for mutual transfers.

- 8. Government after careful examination of the proposals submitted by the Commissioner & Director of School Education and representations received from certain individual teachers withdrawing their willingness given earlier for mutual transfers, here by direct the Commissioner & Director of School Education, Hyderabad to effect the transfer of teachers included in 1st and 2nd proposals duly deleting the names of those teachers who have withdrawn their willingness for mutual transfer subsequently and their counter parts given in the list annexed to this order in relaxation of ban on transfer of employees.
- The Commissioner & Director of School Education, Hyderabad is directed to issue orders effecting the transfer of teachers of various categories working in Government, ZPPs / MPPs on mutual grounds subject to the condition that the percentage of non locals shall not exceed 15% of the cadre strength at any point of time in any unit of appointment and subject to other conditions laid down in circular Memo No.97462 /MC2004-50 GA (MC) Department dt.04-10-2006 and Presidential Order issued in G.O.Ms.No.674 GA (SPF.A) Deptt. dated: 20-10-1975. If in any unit of appointment the percentage of non-locals in any cadre prior to these mutual transfers is already more than 15%, in such cases, such percentage shall* remain same even after these mutual transfers. District Educational Officers concerned shall calculate existing percentage of non-locals in each cadre prior to these mutual transfers and after the mutual transfers and send such report to Government for record. The individuals should be intimated that they are not entitled for TTA and joining time, as the transfers are made on their request. The Inter-District transfers effected are however, subject to final outcome of the SLP pending in the Honourable Supreme Court of India other cases, pending if any before Honourable High Court and Honourable A.P.A.T.
