



**MINUTES OF THE MEETING HELD WITH THE REPRESENTATIVES OF
STATE TEACHERS UNION ON 15-12-2010 AT 4.00 P.M, IN THE OFFICE OF
COMMISSIONER & DIRECTOR OF SCHOOL EDUCATION.**

The Joint Director (S) welcomed the Representatives and requested them to present their grievances.

The President STU explained the circumstances issue of **Dharna** notice and requested to settle the grievances of the teachers submitted by the STU at the earliest.

The General Secretary of STU requested to expedite the pending issues.

The item wise demands are as follows:-

1. The STU representative that during 2009 promotions are given stipulating 31 January 2009 as last date of the counselling for promotions, and there is no uniform dates of promotion and requested to considered a common date as the promotion date for all the Teachers.

This issue will be examined in detailed and STU is requested to give a detailed representation in this regard.

2. Delay in settlement of Medical Reimbursement cases:-

It is informed that the STU that separate software is being developed with the help of officers of director of Medical Education for speedy disposal of Medical cases. Extra staff members will be posted to the Medical bill section to attend to the work and to avoid delay. A citizen charter will also be prepared for speedy disposal. It is also agreed to conduct a special drive to clear the tendency of Medical bills.

3. The issue of Senior/Junior problems of Teachers in seniority:-

The issue will be examining on the case to case basis and orders will be issued as per rules.

4. To fill up the aided posts and take over the Aided Schools in to Govt./ ZPP:-

It is explained to STU that at present that there is ban on the creation and fill up of aided posts and this matter is also pending in the Supreme Court of India.

5. To give salaries to Aided employees from the date of appointment instead of approval date:-

It is informed to STU as per rules issued in GO Ms.No. 1, Edn. Dt. 1-1-1994 their salaries will be paid from the date of approval only.

6. Adjustment of surplus aided teachers in to Govt/ZPP:-

There is no provision to accommodate/ transfer/ observe the aided teachers in to Govt./ ZPP. But however the issue regarding adjustment of surplus teachers to needy school will be examined.

7. Payment of TA / DA to the Teachers transferred and GO 610:-


It is informed to STU that the necessary proposal to Govt. is already sent and the matter is under examination.

8. The STU as put for the following specific issue for settlement:-

- a). STU Lr. No.176/10-11 dt. 20-8-2010 regarding regularization of LFL HM in Nellore and other Dsit.
- b). STU Lr.No. 77/10-11 dt. 21-6-2010 regarding adjustment of teachers working in the against vacancies before allotment of DSC 2008 candidates.
- c). STU Lr.No. 245/10-11 dt. 16-10-2010 regarding regularization of gap period of 7 teachers in Prakasham Dist.
- d) STU Lr. No. 280/10-11 dt. 8-11-2010 regarding retrospective promotion K. Sahadev, SA Adilabad Dist.

It is informed to STU that the above issues will be looked into and settled within 15 days.
