All the District Educational Officers in the State are informed that the GOI vide reference read above have released 1<sup>st</sup> installment of Central Share of Recurring grant (25% of Central Share) i.e., Rs. 1275.51 lakhs. Out of that the following component wise amounts are allocated to each of the 10163 Government Secondary Schools towards School Annual Grant and Minor Repair for 8548 Government Secondary Schools in the State:

Therefore the C&DSE and Ex-Officio Project Director, RMSA, Hyderabad is pleased to sanction and release of an amount of Rs.7425/- (rupees seven thousand four hundred and twenty five only) after deducting an amount of Rs. 75/- (rupees seventy five only) for meeting the expenditure on printing and supply charges of School Academic Calendar 2010-11 in Telugu and English versions @ two per school and Rs. 4687.50 (rupees four thousand six hundred eighty seven and fifty paise only) as Minor

Repair Grant to 8548 Government Secondary Schools directly to the SMDC accounts by way of ECS system through SBI, Red Hills Branch, Hyderabad directly.

The above grant should be utilized by the School Management Development Committees constituted for implementation of CSS RAMSA scheme at school level in the State duly following the terms and conditions stipulated by Government of India.

- (i) Recurring costs as detailed above shall be drawn and utilized during the current financial year 2009-10.
- (ii) The grantee shall keep the amount sanctioned for RMSA under a separate bank account and maintain separate account for its disbursement and expenditure as per rules.
- (iii) It shall be utilized by the grantee only for undertaking activities as proposed in the sanction and in consonance with the norms of expenditure in the scheme.
- (iv) The assets, if any acquired wholly or substantially out of this grant should not be disposed of encumbered or utilized for purposes other than those for which the grant has been sanctioned without obtaining prior sanction of the Government of India.
- (v) The grantee shall maintain a separate and proper account of the expenditure incurred out of the grant and the accounts so maintained shall be open to the audit by the Comptroller and Auditor General of India or by any authority deputed by him for the purpose, as per rules and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever the grantee is called upon to do so.
- (vi) The grantee shall furnish to this Department item wise statement of expenditure on a quarterly basis and other reports on physical and financial progress in approved formats. The grant will be utilized within the current financial year. The grantee will submit annual detailed progress report of the project within one month from the close of the financial year. An annual audited statement of accounts along with a certificate of utilization of the grant in GFR 19-A for the approved project duly signed by a Chartered Accountant and countersigned by an authorized signatory of the project in charge will be submitted to the Ministry within 12 months from the close of the financial year. Grantee has also to submit a copy of annual audited accounts to the office of Director General of Audit, Central Revenues, I.P., Estates, New Delhi-110002 under intimation to this Ministry. The unspent balance if any and interest accrued thereon, will have to be refunded or this shall be taken into account before further installment is released.
- (vii) A register of assets acquired wholly or substantially out of the grant shall be maintained in prescribed form and a certified copy of the register in respect of the assets acquired should be sent to this Ministry not later than one month from the close of the financial year. Such copies should continue to be furnished even after the Government's grant to the Society has ceased. The statement should relate not only to the assets created during the year to which it relates but to all previous assets so created wholly or substantially out of Government's grant upto the end of the period to which the return relates. For purpose of determining whether assets have been created substantially out of the Govt. grant, it is not necessary that the amount utilized out of the Government grant should exceed 50%.

- (viii) The accounts and other records of the Society shall be open to inspection by an officer of the Ministry of Human Resource Development or any other person deputed by the Ministry for this purpose.
- (ix) The grantee shall fully implement the Official Language policy of the Union Government i.e., it shall fully comply with Official Language Act 1963 and Official Language (Use for the official purpose of the Union) Rules 1976 etc.,
- (x) In case the implementing society employing more than twenty person on a regular basis, the provision for reservation for scheduled caste, and scheduled tribes and OBCs in posts and services of the organization will be made as per the State Government rules.
- (xi) Amount will be subject to adjustment against future grants on the basis of expenditure in Audited Accounts for this financial year.
- (xii) Existing staff of the State Govt., should be optimally utilized. The Principal work of project implementation shall be on the mainstream administrative establishment at State and district levels. Staff should be appointed only on contractual basis.
- (xiii) The guidelines issued by the Government of India from time to time regarding monitoring management, and financial control and other procedure would be followed in the execution.
- (xiv) All financial norms for civil works are suggestive and meant for financial estimations. State PWD schedule of rates will be applicable. The RMSA norms prescribed in the Frame work have to be strictly followed.

Further the norms prescribed by GOI on School infrastructure, learning resources, teachers and others from Para 4.1 to 4.8 and from Para 8.3.1 to 8.3.7 on management structure at school level for implementation of RMSA Scheme at school level is herewith enclosed. They are also requested to communicate the same to all the Headmasters of Government Secondary Schools to strictly adhere to the instructions/norms immediately.

Further while communicating a copy of the reference 2<sup>nd</sup> read above they are requested to communicate the same relating to purchase of laboratory equipments and lab consumables (Physical Science, Bio Science and Mathematics) to all the Government Secondary Schools functioning under their control with instructions to purchase the needy and useful items for imparting Science Education to IX and X class studying students in the School subject to condition that "so far as the schools not having proper/functional lab, while spending the funds released for purchase of lab consumables/equipment and only such items may be purchased which are easily storable and would be assist towards gradual building up of a proper lab".

A copy of the list of identified 10163 Government Secondary Schools to which School Annual Grants are released and 8548 Government Schools for which Minor Repair Grant are released are herewith communicated for further necessary follow up action in the matter.

Based on the sanctions, funds were released to all the Secondary Schools in the State under Recurring Grants in the sanctioned components during the year 2009-10 & 2010-11 with instructions to utilize the Grant released by the School Management Development Committees constituted for implementation of CSS RMSA Scheme at School level in the State duly following the Terms & Conditions stipulated by GOI, MHRD, New Delhi and communicated vide references 3<sup>rd</sup> & 6<sup>th</sup> read above including the norms prescribed by GOI on School infrastructure, learning resources, teachers and others from Para 4.1 to 4.8 and from Para 8.3.1 to 8.3.7 on management structure at school level to strictly adhere to the instructions/norms.

Further while communicating a list of Laboratory Equipments & Lab Consumables (Phy.Science, Bio.Science & Mathematics) of the Director, SCERT received through the reference 2<sup>nd</sup> read above to all the Secondary Schools in the State they have been requested to instruct the concerned to purchase the needy and useful items for imparting Science Education to IX & X Class studying students in the School subject to condition that "so far as the schools not having proper/functional lab, while spending the funds released for purchase of lab consumables/ equipment and only such items may be purchased which are easily storable and would assist towards gradual building up of a proper lab".

Keeping in view of the observations made by the District Educational Officer, Inspecting Officers at Secondary School level and requests made by them, to have an idea in purchasing of books, periodicals, Science material etc. at School level, keeping

in view of the norms prescribed by GOI, MHRD, New Delhi in the RMSA Frame Work a Committee was constituted to recommend the lists of books which are very useful at School level both for Teachers and Students.

The Committee members further gone through the "Manual on Science laboratory kit at Secondary level" provided by NCERT, New Delhi and the information provided by Prof.& Head, Workshop Department, NCERT, New Delhi.

It is unanimously recommended to suggest to procure NCERT, New Delhi designed and developed Secondary Science Kit (SSK) as per the scale recommended here under.

As the Science Kit (SSK) contains only Physics, Chemistry and Biology subjects the committee recommended to procure Mathematics Kit also separately designed and developed by the NCERT, New Delhi viz. Rapsons Laboratory Services, Ambala Cantt, Chinar Scientific Industries, New Delhi & M/s Apollo International, Indore and at the rates fixed by NCERT.

The Committee also suggested to follow the break up as here under:



1. Purchase of Kits including Mathematics Rs. 22,000/-
2. Purchase of Science charts and models Rs. 1,000/-
3. Purchase of Lab consumable articles Rs. 1,500/-
4. Maintenance, Replacement & Repair of the Lab equipment Rs. 500/-

In addition to the above they have also requested to follow the following guidelines scrupulously in selecting the Books etc. purchasing under School Annual Grants:

- When book reading is going down steeply, only the books that are reprinted many times stand out as useful and popular books. It can be a right guideline to purchase the books that are reprinted more than three times.
- General books in Physical & Social Sciences and Literature should be preferred.
- Books that inculcate a sense of patriotism and love for is culture may be procure.
- Books on great Nation builders and National leaders that inspire younger generation for a better future India need to be included i.e., Vivekananda, JC Bose, APJ Abdul Kalam etc.
- Books that inculcate human values among children need to be included.
- In schools, youngsters are in formative stage and the books, which impart knowledge about their life, will serve definite purpose than the books that impart general knowledge about the outside world. Books, which are useful in day-to-day life, are to be preferred.
- Most of the youngsters entertain negative feelings like shyness, fear, anxiety, low opinion about themselves. To help young students to come out of such feelings and to build confidence, all sensible books on personality development are to be preferred.
- Books that are popular and sold in good number in bookshops are to be preferred to the books that are mainly published for supply to libraries and other institutions only.

- Books which help both parents and teachers alike, to adopt the right attitude while dealing with growing minds that explain the behaviour of teenagers and the best possibilities to deal with them are to be preferred.
- Books, which help youngsters to understand basic techniques of preparing for exams and to face them successfully, are to be preferred.
- Most of the rural students are haunted with anxiety, tension, insecurity, inadequacy feelings and easily get into depression. Books, which explain at great length how to understand abnormal behaviour in the early stage and the methods to correct it and suggest the ways to develop healthy attitude, should be procured.
- Since two decades quality fiction is not being published in Andhra Pradesh. Hence purchase of fiction books can be limited to 10% of total purchases.

Hence, after examining the recommendations of the Committee in detail, the Commissioner and Director of School Education & Ex-Officio Project Director, RMSA is pleased to approve their recommendations for utilizing the School Annual Grants in-to-to. Therefore all the Head Masters/ Principals & Chairmen of School Management Development Committees of identified Secondary Schools & all the District Educational Officer & Ex-Officio District Project Coordinators in the State are requested to follow the above guidelines strictly while utilizing the School Annual Grants released from this office every year from time to time. Any deviation in diverting the funds from one component to another component or otherwise will be viewed seriously.
