In the G.O.1st read above, orders were issued for implementation of Employees Health Scheme (EHS) which is intended to provide cashless treatment to the State Government Employees / Pensioners and their dependent family members in empanelled network hospitals. In para 7.2 of the said G.O., under 'Implementation Mechanism, the following is mentioned:

"A Steering Committee under the chairmanship of Chief Secretary to Government will review the implementation of the Scheme from time to time. the Steering Committee will meet as frequently as required, discuss, monitor and review the Scheme, benefit packages, grievances, quality of medical care including the modalities of an Employees Health Trust. The General Administration (Services & HRM) Department will issue orders forming the Steering Committee with 40% members from employees and pensioners associations, and 60% members from Government."

- 2. In the U.O. note 2nd read above, the HM&FW (M2) Department have requested the G.A.(SW) Department to take action to constitute a Steering Committee headed by Chief Secretary to Government in terms of para 7.2 of G.O. 1st read above.

Chief Secretary to Govt., Planning Department with the following members to recommend the Associations which should be represented as members from the Employees and Pensioners Associations on the Steering Committee:

 - 2. Sri S.K.Sinha, IAS ... Member Prl. Secretary to Govt. (Ser. & HRM)
 - 3. Sri Ajay Sawhney, IAS ... Member Prl. Secretary to Govt., Health, Medical & Family Welfare Dept.
 - 4. Dr. P.V.Ramesh, IAS ... Member Prl. Secretary to Govt., Finance (R&E) Dept.

- 5. Sri Rajeshwar Tiwari, IAS ... Member Prl. Secretary to Govt., School Education Department
- 4. The Committee should make recommendations as to which Unions / Associations should be represented against six members to be nominated as Members from the Employees Unions on the Steering Committee. The Committee should make a recommendation as expeditiously as possible.
