**ORDER:**

In the reference 1<sup>st</sup> read above, the Hon'ble Minister for Finance has indicated to review and revamp the functioning of the Directorate of Insurance based on the discussion held in the meeting. The need for applying towards Insurance can be dispensed with as it is a compulsory Scheme and every employee on appointment to Government service would be a deemed policy holder of A.P.G.L.I. The possibilities of inclusion and exclusion of certain activities in the functioning of the Directorate of Insurance can be considered. This is to make the Department of Insurance more dynamic and give better service to the employees. The Department of Insurance can also shed the drudgery of cumbersome routine activities and concentrate more on the qualitative and efficient functioning of the Department covering more service personnel of Government into its fold.

2. In the reference 2<sup>nd</sup> read above, the Director of Insurance, A.P., Hyderabad has requested the Government to kindly consider forming a Committee to study the possibilities of some modifications in the procedures of the Department on the following :-

1. Since it is a compulsory scheme whether the submission of proposal Forms and issue of Policies is required or giving policy on the deemed basis may be examined duly keeping some checks.
2. Whether two separate Schemes i.e., A.P.G.L.I and G.I.S. are necessary or one Scheme is sufficient to achieve the objectives duly giving some modifications.
3. On-Line payments for Loans and Claims and possibilities of its Payment on the day of superannuation.
4. Additional inputs for strengthening the Department for rendering more efficient service.
