While communicating a copy of the Govt. Memo. 1st read above without any deviation and to issue posting orders in the existing vacancies. Further, the teachers may be directed to take relief from their respective old stations immediately and join in their new place of posting on **22/02/2010**.

In this context, they are informed that if any transferred teacher is not participated in the transfer counseling, he/she will forfeit the right of his/her transfer and no claims will be entertained at a later date. However, the DEOs have to complete the entire exercise by **22/02/2010** and submit the compliance by the evening without fail.
